

This page explains how we handle and process the personal data of visitors to our website. This notice applies to this website only and not to any other websites which the user may visit via links.

SCOPE OF DATA PROCESSING Data referring to identified or identifiable persons may be processed as a result of visiting this website. Processing related to the web services of this site is performed only by technical staff employed at the office in charge of data processing operations or occasionally by other individuals responsible for occasional maintenance tasks. The data may also be processed by designated persons involved in the management of the information system in the name of and on behalf of the company. Personal data voluntarily provided by users who use the website functions or who submit requests for information are used for the sole purpose of providing the service or assistance requested. To that end, the personal data of users may be disclosed to parties, so they are able to carry out the related processing and disclosures, in the following categories: entities that provide services for the management of the company's information system; entities that carry out document storage activities; consultants; entities engaged in inspection, auditing and certification of the Company's activities.

The entities belonging to the above mentioned categories shall use the data received in their capacity as autonomous "Controllers", except where they were appointed by the company for processing within their specific competence. The personal data of users are not disseminated.

DATA PROCESSING METHODS AND DATA RETENTION PERIODS Personal data, including data provided voluntarily by the user, are processed using manual tools and automated means for the time strictly necessary to achieve the purposes for which they were collected. Except for cases where data is processed for legal purposes and to ascertain responsibility in the event of possible cybercrimes to the detriment of the website, data provided voluntarily by users is stored strictly for the time necessary to respond to requests and for statistical purposes. Specific security measures are implemented to prevent data loss, unlawful or incorrect use, and unauthorized access.

COOKIES - Cookies consist of portions of code installed in the browser that assist the Owner in providing the Service according to the purposes described. Some of the purposes for which Cookies are installed may also require the User's consent.

Technical Cookies and Cookies serving aggregated statistical purposes

This Application uses Cookies to save the User's session and to carry out other activities that are strictly necessary for its operation, for example in relation to the distribution of traffic.

Activity regarding the saving of preferences, optimization, and statistics

This Application uses Cookies to save browsing preferences and to optimize the User's browsing experience. Among these Cookies are, for example, those used for the setting of language or for the management of first party statistics by the Owner of the website.

Other types of Cookies or third parties that install Cookies

Some of the services listed below collect statistics in an anonymized and aggregated form and may not require the consent of the User or may be managed directly by the Owner – depending on how they are described – without the help of third parties.

If any third party operated services are listed among the tools below, these may be used to track Users' browsing habits – in addition to the information specified herein and without the Owner's knowledge. Please refer to the privacy policy of the listed services for detailed information.

Which Personal Data are processed depends on the characteristics and mode of implementation of these services, whose function is to filter the activities of this Application. Given the distributed nature of this system, it is difficult to determine where the contents - which may contain the User's Personal Data- are transferred.
